Received some new interest from Eagle on having a glass recycle center like the one in Plattsmouth. Board in agreement that it would be good to consider something for the west side of the county, since a lot of our efforts tend to focus on the east side.

- 2. **Clothing Giveaway Event** March 15th with One Life church; no more donations needed. Expecting a good turnout.
