# **OLD BUSINESS**

- \*Minutes presented for June Monica approved, and Jim gave second approval.
- \*June treasure report Rachel saw no issues Liz motion to approve and 2<sup>nd</sup> by Monica

# **NEW BUSINESS**

- \*New Business Dana made a sign-up sheet and link to work the fair for volunteers she will be sharing via Facebook and Cindy will do with Newsletter. Dana plans to have Sydney working at the table/booth at the fair. Monica gave the idea that for each hour a volunteer works at the fair they would receive a ticket to put in for gift cards, Monica would get one, Cindy is getting one from Hy-Vee for Starbucks, and the rest of the board would get some as well. This would help be an incentive to get more volunteers. Sydney would be able to give them a ticket when they worked their shift, and she could track that for KCCB.
- \*Moving the August board meeting from Aug 6 to Aug 13<sup>th</sup> since that is when the fair starts, Dana can give a full report of the fair at this time.
- \*Dana & Cindy will be working on signage to maybe place at all tables, trash cans, concession stands that stand out to help people understand and use the recycling bins. The hope is to find ways to teach, inspire, and use the recycling bins.
- \*NDEE grant update Dana is checking for date to start should be coming up soon still trying to find ways to get the money since no volunteer hours are able to be used. Grant is due mid-August so will be working on that.
- \*Applying for NRC grant for truck for KCCB. Must be submitted by 7/15/25. Dana went to Copple, Woodhouse, Gregg Young, and Henry's and looked at 4 different trucks with mileage from 50000-90000 miles with the most expensive being \$30000. Grant would be for \$25000 and KCCB would be resp for the other \$5000 Roger and Linda give KCCB \$5000 we could use that money for that. The truck would have a tow package, 4 wd, and quad cab. We will know within a week after filed if we get it.
- \*Trailer was scratched at one of the Recycling events Dana checked into insurance, and we have a \$500 deductible she talked to Gregg Young auto body, and they said could touch it up for \$250 or if did the whole panel it would be around \$500. It would cover up current signage though. The board agreed to just have Dana have it touched up.
- \*KAB grant Dana working on this month \$2000 for recycling bins for Plattsmouth and Murray 2 at each location. The total cost would be \$3500. Plattsmouth – Emily wants a certain color which is more, and they don't really have

it. Monica told Dana to cc her in at her Flood email and hopefully that would inspire Emily to pick colors that are in stock, or city can pay the difference.

- \*New Plattsmouth High School Principal Tina Harvey asked Dana for funding and ideas for a water bottle refill station for HS. Discussed maybe offering half if we can have a plate with our logo she will contact Tina maybe Rotary or another organization can help.
- \*Dana has had a dumpster at her house for her and Cindy to do recycling great saves on mileage and is only accessible to them.
- \*Dana discussed what a great job Sydney is doing with her part in KCCB she averages about 10 hours a month Dana would like to give her a raise from \$15 to \$18 an hour. The board agreed but stated that only during fair month could she go to 80 hours at that rate since that would be the busiest time for her, as she will be back in school in Sept. She would then go back to 20 hours a month and maintain the \$18 an hour.
- \*Dana commented that Liz worked at the Garden Event, and she was very thankful. Liz said it was a great event.
- \*Karen brought up that the recycling bins Dana would be getting seemed smaller than what Louisville had even though Linda told her past size purchased. Dana would follow up and confirm the correct size.
- \*Jim brought up that KCCB has not had more money from the county, Dana said she usually just invoices for \$10000 and attends the meeting to justify what we do. Jim says we need to meet with Dwaine Murdoch and ask for more say \$15000 this year with \$5000 increments for each year out for all we do for Cass County. The board agreed so Jim will set up a meeting with Dana and Dwaine and himself and Cindy to try and get this going.
